ARTICLES OF INCORPORATION

OF

We, the undersigned being of lawful age, for purposes of forming a non-profit corporation pursuant to Minnesota General Statutes, 1961, Chapter 317, and laws amendatory thereof, do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be Red Baron Flyers, Inc.

ARTICLE II

The general purpose of this corporation shall be to own or lease and maintain one or more aircrafts for the education, transportation, and general use of the members of this corporation or their families or such individuals as the board of directors may designate pursuant to any by laws which may be hereinafter adopted.

To acquire, hold, sell, lease, pledge, mortgage or otherwise dispose of any property whether realty or personalty necessary to the operation of the corporation and to the accomplishment of its purposes.

To borrow money, contract debts, make contracts and to exercise any and all other powers as a natural person could lawfully make, do, perform or exercise which may be necessary, convenient, or expedient for the accomplishment of any of its objects or purposes, providing the same be not inconsistent with the laws of the State of Minnesota and to that end enumeration of such powers shall not be deemed inclusive.

ARTICLE III

The corporation shall afford no pecuniary gain, directly or indirectly, to any of its members, directors or officers

ARTICLE IV

The duration of this corporation shall be perpetual.

ARTICLE V

The principal place of business of this corporation shall be Caledonia, Minnesota.

The time and place of annual meetings, notices of the annual and any special meetings and the manner of calling special meetings shall be as provided for in the by laws.

ARTICLE XI

The officers of the corporation shall be a President, Vice-President, Secretary and Treasurer and shall be elected by the board of directors from their number at a meeting to be held the day of the date of the annual meeting of the membership and immediately following the said annual meeting of the membership.

The first officers of this corporation who shall hold office until their successors are elected and qualify are:

These articles may be amended in the manner and as provided for by law.
